- 5. This Order applies to the IBEW Local No. 461 Defined Contribution Pension Plan (the "Plan"). This Order also applies to (a) any benefits accrued by the Participant under a predecessor qualified retirement plan that were transferred into this Plan, and (b) any successor to the Plan to which liability for the Participant's benefits is transferred. Any changes in the Plan Administrator, Plan Sponsor or Plan name will not affect the Alternate Payee's rights awarded under this Order.

AWARD OF BENEFITS

The Order assigns the Alternate Payee, as separate property, a portion of the assets credited to the Participant's account under the Plan as follows:

1. <u>Amount of Benefit</u>. The Alternate Payee is assigned:

Option 1: _____% of the Participant's total account balance under the Plan as of the Assignment Date.

Option 2: The lesser of \$_____or 100% of the Participant's account under the Plan as of the Assignment Date.

The amount assigned to the Alternate Payee pursuant to this Order will be made on a pro-rata basis from all contribution sources attributable to the Participant's total account. To the extent necessary, the Plan Administrator will substitute any Plan asset of comparable fair market value, as practicable, to assign the Plan assets. This allocation will include all investment funds in which the Participant's account is invested as of the date the Plan Administrator segregates the Alternate Payee's benefit.

(a) <u>Valuation of Participant's Plan Account</u>. The Plan Administrator will value the Participant's Plan account as of the Plan's valuation date coincident with or immediately preceding the Assignment Date. The Alternate Payee is not entitled to any

contribution(s) made by, or on behalf of, the Participant or forfeitures which are allocated subsequent to the Assignment Date.

(b) <u>Earnings</u>. The Plan Administrator [*will/will not*] adjust the Alternate Payee's benefit by a proportional share of all earnings (gains or losses) allocated to the Participant's account from the Assignment Date until the date the Plan Administrator segregates the Alternate Payee's benefit into a separate account.

- 2. <u>Account Segregation</u>. The Plan Administrator will segregate the Alternate Payee's benefit into a separate recordkeeping account as soon as administratively feasible following the Plan Administrator's determination that this Order constitutes a Qualified Domestic Relations Order ("QDRO") and either (a) the parties have waived the applicable 60-day review period, or (b) the review period expires. The Plan Administrator will administer the Alternate Payee's account according to the Plan as a separate and distinct account, including the allocation of earnings. The Participant is divested of all right, title and interest in the Alternate Payee's account. The Participant retains all other value, benefits and interest in the Participant's remaining account.
- 3. <u>Investment</u>. Once the Plan Administrator segregates the Alternate Payee's benefit into a separate account, the Alternate Payee may direct the investment of the account pursuant to the Plan. As a beneficiary of the Plan, however, the Alternate Payee may not receive additional contributions unless (s)he is also a Plan participant.
- 4. Timing and Form of Distribution. Distribution of the Alternate Payee's benefit will not be made until the Plan Administrator has issued a written determination that this Order constitutes a ODRO and any period of review under the Plan's ODRO Procedures has either expired or been waived by the parties to this Order. If the Alternate Payee's benefit is subject to a mandatory cash-out of small accounts under the Internal Revenue Code and the terms of the Plan, the Plan Administrator will initiate a distribution of the Alternate Payee's benefit in a single lump sum as soon as administratively feasible following the Plan Administrator's determination that this Order constitutes a ODRO. If the mandatory cash-out provisions of the Plan do not apply to the Alternate Payee's benefit, the Alternate Payee may elect to receive a distribution as soon as administratively feasible following the Plan Administrator's determination that this Order constitutes a ODRO and either (a) the parties have waived the applicable 60-day review period, or (b) the 60-day review period expires. The Alternate Payee may elect distribution in any form available under the Plan for alternate payees, except for a joint and survivor annuity with his or her subsequent spouse. The Alternate Payee, however, must request a distribution no later than the required beginning date specified by the Plan.
- 5. <u>Beneficiary Designation</u>. The Alternate Payee may designate a beneficiary for *[his/her]* account by properly completing and filing a beneficiary designation according to the Plan's administrative procedures. If the Alternate Payee fails to properly designate a beneficiary or if the beneficiary is deceased, the Plan Administrator will distribute the Alternate Payee's remaining account (if any) according to the Plan's terms for participants who do not have a valid beneficiary designation in force at death.

The Participant must designate a beneficiary for [*his/her*] remaining account by properly completing and filing a beneficiary designation according to the Plan's administrative procedures. The Participant's previous designation of [*his/her*] (former) spouse is automatically void upon legal termination of the marriage by divorce. The Participant, may, however re-designate [*his/her*] (former) spouse as [*his/her*] beneficiary after the date of legal termination of the marriage.

- 6. <u>Alternate Payee's Death</u>. The Alternate Payee's death will not affect the Participant's remaining account. The Plan Administrator will not restore the Alternate Payee's account to the Participant when the Alternate Payee dies. The Participant will not be entitled to any death or survivor benefits when the Alternate Payee dies, unless the Alternate Payee has properly designated the Participant as [*his/her*] beneficiary.
- 7. <u>Participant's Death</u>. The Participant's death will not affect the Alternate Payee's benefit pursuant to this Order. The Alternate Payee will not be entitled to any death or survivor benefits as a result of the Participant's death, unless the Participant has properly designated the Alternate Payee as [*his/her*] beneficiary.

OTHER TERMS AND CONDITIONS

- 1. <u>Reimbursement/Inadvertent Payment(s)</u>. The Alternate Payee or the Participant under this Order will promptly reimburse the Plan for any benefits wrongfully or mistakenly received from the Plan.
- 2. <u>Tax Treatment</u>. For purposes of Internal Revenue Code section 402(a)(1) and section 72, any Alternate Payee who is the Participant's spouse or former spouse will be treated as the distributee of any distribution or payments made to the Alternate Payee under this Order, and as such, will be required to pay the appropriate federal income taxes on such distribution.
- 3. <u>QDRO Fee</u>. A separate, one-time processing fee in the amount of \$300 applies to cover the administration of this Order as a QDRO. This fee will be deducted equally from the Participant's and Alternate Payee's accounts (\$150 from each account). However, the entire \$300 will be deducted from the Alternate Payee's account if the Alternate Payee is assigned 100% of the Participant's total account.
- 4. <u>Status of the Order</u>. This Order is intended to constitute a Qualified Domestic Relations Order pursuant to Internal Revenue Code section 414(p) [26 USC § 414(p)] and the Employee Retirement Income Security Act section 206(d) [29 USC § 1056(d)]. This Order will be administered and interpreted in conformity with these statutes, as amended from time to time, and any applicable regulations.
- 5. <u>Jurisdiction</u>. The Court retains jurisdiction to amend this Order, but only for the purpose of establishing or maintaining its qualification as a Qualified Domestic Relations Order; provided that: (a) no such amendment will require the Plan to provide any type or form of benefit, or any option not otherwise provided under the Plan and (b) no such amendment or the right of the Court to amend will invalidate this Order as "qualified."
- 6. <u>Plan Termination</u>. In the event of a Plan termination, the Alternate Payee will be entitled to receive [*his/her*] portion of the Participant's benefits according to the Plan's termination provisions for participants and beneficiaries.
- 7. <u>Notification of Permanent Address</u>. The Participant and the Alternate Payee will at all times keep the Plan Administrator informed of their respective permanent addresses.
- 8. <u>Copy to Plan Administrator</u>. The parties will provide a certified copy of this Order to the Plan Administrator. This Order will take effect immediately and remain in effect until further Order of the Court.
